Statement of Facts:

During a campaign in Fort Walton Beach for City Council Larry Patrick ran as a candidate. There were many who knew that this person did not live in the city limits and had not for many years. Although he does have property he owns in the city limits that he had once lived in. During a campaign forum he mentioned that he was going to sell his home where he lived in part time and was going to move back into Fort Walton Beach home full time in the near future.

Many citizens and other candidates running for office knew he did not live in the city even part time and tried to get this rectified with the Supervisor of Elections Paul Lux. He was made aware of this but was unable to do anything as he said, "I don't have any proof that he isn't living in the city limits and can't do anything about this". There was a non-resident who had obtained information about this but once again, Paul Lux said "it had to come from a city resident" as someone that just owned a business didn't have any standing or say. All those that knew the truth were less than thrilled about this, knowing that he was lying about his residency and felt helpless and frustrated. So the election continued and due to some negative campaigning by this person – he won. (yes beside the point) The residents and candidates that knew all this were hoping that justice would prevail at the polls but it did not.

So a group of people that want truth to prevail, hired a private investigator after several months of getting nowhere with local authorities/elected officials to obtain some proof one way or another from a non-biased entity. After obtaining the report from the PI, it was of his opinion that he did not live in the city limits but in fact – at the home in Niceville he moved into once he left his residence in Fort Walton Beach.

One of the reasons that Paul Lux said he had to believe Larry Patrick was that his "Homestead" property was still in Fort Walton Beach. This is another problem – he has falsified the homestead property for many, many years. More to come on this in the exhibits that are attached.

As a City Council Member – you are held to a higher standard, and this is not a higher standard. If this person lies as to where he lives, what will he lie or deceive the city and its residents. We are very concerned as to his actions prior to the election and post-election.

So here is the background as to why we are filing these papers with all the entities as there is fraud and deceit behind all the paperwork starting with the filing package. Evidence/facts is attached.

"Page 1 - As per the State of Florida a Homestead Property is your primary residence and Homestead can only be used in or on a residence you live in. This document shows that "Homestead" has been on that property as far back as the records would show, back to 2011. But many people knew this to be false. This is a small community, and many are still wondering how he pulled this off with living in Niceville. This has been brought to the Property Appraisers Office 2 times and somehow managed to convince that office that he was living there. Hearsay – showed utility bills with his name on it based on what the Tax Collector said as well as the Supervisor of Elections.

*Page 2 – As of June 26th, 2023 or shortly before this date – Homestead has been removed from the 221 Yacht Club Dr Fort Walton Beach. Why would a person that lived there remove "Homestead" if you live there? Have not been able to obtain information on how that came to be.

INVESTIGATION REPORT ON SUBJECT LARRY B PATRICK

On June 07, 2023, contacted the offices of Bluewater Investigations to request an investigation be conducted on his behalf. The purpose of the investigation was to determine the home address Larry B Patrick, herein known as "Subject" was residing.

On June 29, 2023, at approximately 5:30pm investigator arrived at 9009 Rushing River Way, Niceville, Florida. Upon arrival a maroon Jeep Cherokee was located parked in the driveway. Several minutes a later a white female and a white dog were seen in the driveway of the home. The female walked to retrieve the fame, followed by what appeared to be pulling a few weeds in the yard. A search of Subjects social media showed multiple photos of this same woman, and what appears to the be the same white dog. The investigator departed this area to check on another address provided to our office. The Subject has been known to visit located at 221 Yacht Club Drive, Fort Walton Beach, FL. Upon arrival the investigator noted a black truck at this address, but no indication anyone was home as there was no movement seen. The investigator returned to Subjects in Niceville. At approximately 8:28pm a red Jeep Wrangler matching the description and tag number as that of the Subject was seen pulling into the neighborhood. The vehicle was monitored pulling into the Subjects home address. An adult male matching the description the Subject exited the vehicle and walking in the front door. The investigation was maintained into the late evening however lights were going out in the home with no further movement. It was determined Subject would be spending the night at this home.
